**REFERENCE.** Peddling

**GENERAL.** No person shall engage in peddling in the Borough of South Greensburg without first having taken out a license as herein provided.

**REGULATIONS.** See REVERSE SIDE for Regulations and Conditions governing peddling upon proper approval.

**APPLICATION.** At least two (2) days before the date of requested peddling, applicants for a Peddler's License shall complete and file with the Borough Secretary this application for approval.

## **REGULATIONS & CONDITIONS - Peddling**

Upon being granted approval by the Borough to engage in peddling, the following regulations and conditions will apply:

- Every peddler shall at all times when engaged in peddling in the Borough of South Greensburg, carry such Peddler's License upon his person and shall exhibit such license, upon request, to all police officers, Borough officials and citizens.
- No peddler shall engage in selling any product not mentioned upon such license nor shall any person having a foot Peddler's License operate from or with any motor vehicle.
- No person licensed as a peddler under Chapter 122 of the Code of Ordinances shall hawk or cry his wares upon any of the streets or sidewalks of the Borough, nor shall he use any loudspeaker or horn or any other device for announcing his presence by which the public is annoyed.
- No person licensed as a peddler under Chapter 122 of the Code of Ordinances shall park any vehicle upon any of the streets or alleys of the Borough in order to sort, rearrange or clean any of his goods, wares or merchandise; nor may any such person place or deposit any refuse upon any of such streets or alleys; nor may any such person maintain or keep a street or curbstone market by parking any vehicle upon any street or alley in the Borough for longer than necessary in order to sell therefrom to persons residing in the immediate vicinity.
- No person licensed as a peddler under Chapter 122 of the Code of Ordinances shall occupy any fixed location upon any of the streets, alleys or sidewalks of the Borough for the purpose of peddling, with or without any stand or counter.
- Hours to engage in peddling are limited to 9:00 A.M. to 5:00 P.M. daily.
- By signing this application, applicant indicates that they understand and agree to comply with the requirements listed herein.
- Any person violating the provisions of Chapter 122 of the Code of Ordinances governing peddling shall be subject to arrest and prosecution pursuant to the criminal statutes of the Commonwealth of Pennsylvania.
