

**BOROUGH OF SOUTH GREENSBURG

Council President Donald Miller called the meeting to order at 7:00 P.M.

I. CENTRAL WESTMORELAND COUNCIL OF GOVERNMENTS REPRESENTATIVE: A motion was made by Iezzi/S. Hixson to re-appoint Margaret Hixson as representative to the Central Westmoreland Council of Governments. VOTE: 7 Yes, 0 No - Motion carried.
