

ORDINANCE NO. 2-2017

**AMENDING CHAPTER 159 OF THE BOROUGH OF SOUTH GREENSBURG CODE,  
DESIGNATING THE PORTION OF OAK STREET BETWEEN JAMISON AVENUE  
AND SHERIDAN AVENUE AS A ONE WAY STREET**

**WHEREAS**, Oak Street in the Borough of South Greensburg forms the north-west boarder of South Greensburg Municipal Park, which is used by children in the community; and

**WHEREAS**, the Borough has determined that it is in the best interests and safety of the community that this portion of Oak Street be designated as a one-way street, traveling in the southerly direction; and

**WHEREAS**, the Borough has determined that the designation of Oak Street as a one-way street complies with 67 Pa.Code §212.113, as the traffic flow can be accommodated in both directions, the street has a reasonable number of intersections for entrance to or exit from the one-way street, the terminal points of the one-way street provide satisfactory transitions to and from the two-way operation, there will be a reduction of intersection delays, existing bus routes can be satisfactorily accommodated, and emergency vehicles can reasonably and expeditiously reach their destinations; and

**WHEREAS**, the Borough is permitted, pursuant to South Greensburg Borough Code Sections 159-2 and 159-13, to regulate the use of roadways within the jurisdictional limits of the Borough, including the designation of streets as “one-way” streets; and

**WHEREAS**, the Borough desires to amend the South Greensburg Code to reflect the designation of this portion of Oak Street as a one way street.

**NOW, THEREFORE**, be it enacted and ordained by Counsel of the Borough of South Greensburg in a regular meeting assembled and by authority of the same:

SECTION 1. The Borough of South Greensburg Borough Code is hereby amended as follows:

A. Section 159-40 is amended to insert, following the entry of “Huff Avenue” and prior to the first entry of “Jamison Avenue,” the following:

<b>Name of Street</b>	<b>Direction of Travel</b>	<b>Prohibited Turn</b>	<b>At Intersection of</b>
Jamison Avenue	East	Left	Oak Street
Jamison Avenue	West	Right	Oak Street

B. Section 159-42 is amended to insert, following the entry of “Keystone Street” and prior to the entry of “Pine Street,” the following:

<b>Name of Street</b>	<b>Direction of Travel</b>	<b>Limits</b>
Oak Street	South	From Sheridan Avenue to Jamison Avenue

C. Section 159-44 is amended to strike and remove the following entry:

<b>Stop Sign on</b>	<b>Direction of Travel</b>	<b>At Intersection of</b>
Oak Street	North	Sheridan Avenue

D. Section 159-48 is amended to strike the “Location” portion of the existing “Oak Street” entry, and replace the same as: “From Coulter Avenue to Jamison Avenue.”

SECTION 2. That the Mayor, Borough Council President, and Borough Secretary of the Borough of South Greensburg, and/or any other proper officer or employee of the Borough of South Greensburg, are hereby authorized and directed to take any and all action necessary to carry into effect this ordinance, including the ordering and placing of appropriate roadway signage, and to sign any and all necessary documents required to carry into effect this Ordinance.


SECTION 3. All ordinances or parts of ordinances which are inconsistent herewith are hereby repealed.

SECTION 4. This ordinance is effective immediately.


