

**BOROUGH OF SOUTH GREENSBURG
REGULAR COUNCIL MEETING
JANUARY 10, 2011**

Council President Donald Miller called the meeting to order at 6:30 P.M.

All those present repeated the Pledge of Allegiance to the Flag.

CITIZEN'S REMARKS:

None.

APPROVAL OF PREVIOUS MEETING'S MINUTES: The minutes of the regular meeting held on December 13, 2010 were approved as presented to each Council member.

CORRESPONDENCE: The Borough Secretary read monthly correspondence and copies were given to each Council member.

COMMITTEE REPORTS:

MAYOR: Mayor Dobies presented the Police report for December: 133 incidents, 73 citations, 4 parking notices, 7 arrests, 1,973 miles logged on the cars and \$2,069.85 collected in fines and reports. 2010 Annual Report: 1,580 incidents, 720 citations, 42 parking notices, 87 arrests, 12 juvenile arrests, 54 ordinance violations, 27,113 miles logged on the cars and \$20,787.71 collected in fines and reports.

POLICE & EMERGENCY MANAGEMENT: Mr. Furin presented his Emergency Management report.

BUILDINGS & GROUNDS: Mr. Todaro said the second police car will be parked in the side lot during business hours and in the evenings.

STREETS & SANITATION: Mr. Yarnell presented the Foreman's report for December. He said the crews will stop plowing and salting after 7:00 P.M. and resume at 4:00 A.M. in the morning.

FIRE & WATER: Fire Chief's report for December: 52 alarms and drills. Truck mileage: 134 miles on the 1994 rescue truck, 148 miles on the 2008 engine and 31 miles on the 2004 squad truck. Total man hours: 40.7. 2010 Annual Report: 435 alarms and drills. Truck mileage: 1048 miles on the 1994 rescue truck, 1790 miles on the 2008 engine and 571 miles on the 2004 squad truck.

PARKS & RECREATION: No report.

PLANNING, ZONING & SHADE TREES: Mr. Martin presented the Zoning Officer's report for December: 1 building permit, 1 occupancy permit and 1 sign permit for a total of \$444.80.

SOLICITOR'S REPORT: No report.

ENGINEER'S REPORT: No report.

SEWAGE AUTHORITY REPORT: Mr. James Roman reported that the Sewage Authority was working on repairs at the treatment plant and will be replacing two lines on East Pittsburgh Street near Greensburg VFD No. 7.

FINANCIAL REPORT: The financial report for December was presented by Mr. Kunkle. A motion was made by Martin/Iezzi to acknowledge receipt of the financial report. VOTE: 6 Yes, 0 No - Motion carried.

UNFINISHED BUSINESS:

A. **ORDINANCE NO. 2011-03:** Mr. Fedele said the ordinance was approved by DCED and is required by law. A motion was made by Iezzi/Yarnell to adopt Ordinance No. 2011-03, revising the floodplain management ordinance and maps. VOTE: 6 Yes, 0 No - Motion carried.

B. **CLICK IT OR TICKET PROGRAM:** Mrs. Iezzi referred to the report on the Click It Or Ticket Program submitted by Chief Scott Fanchalsky. \$1,054.50 in fines was received from 61 citations. There are also 51 citations still to be decided on.

NEW BUSINESS:

A. **ORDINANCE AMENDMENTS:** After a general discussion about the problem with cats, this matter was tabled until the next regular meeting.

B. **LIQUOR LICENSE TRANSFER:** A motion was made by Martin/Iezzi to approve a resolution authorizing the transfer of Pennsylvania Liquor License No. R-7181 from Latrobe, Pennsylvania to South Greensburg, Pennsylvania, for use at premises designated at 1517 Broad Street, South Greensburg, Pennsylvania, subject to compliance with all Borough Ordinances, all applicable permits and licenses and all other laws and regulations. VOTE: 6 Yes, 0 No - Motion carried.

APPROVAL OF BILLS: A motion was made by Yarnell/Martin to authorize payment of the list of bills as presented by the Borough Secretary. VOTE: 6 Yes, 0 No - Motion carried.

ADJOURNMENT: A motion was made by Iezzi/Hixson to adjourn the meeting. VOTE: 6 Yes, 0 No - Motion carried.
