

ORDINANCE NO. 2013-06

AN ORDINANCE OF THE BOROUGH OF SOUTH GREENSBURG, WESTMORELAND COUNTY, PENNSYLVANIA, AMENDING THE ZONING ORDINANCE OF THE BOROUGH OF SOUTH GREENSBURG, DATED THE 13TH DAY OF DECEMBER, 1993, TO CHANGE SECTION 163-19.J., CONVENIENCE COMMERCIAL DISTRICT, AS AMENDED BY ORDINANCE NO. 2012-06, TO PERMIT LIVE ENTERTAINMENT OR DANCING ON A LIMITED BASIS.

The Borough of South Greensburg hereby ordains as follows:

Article V, C-1 Convenience Commercial District of the Zoning Ordinance of the Borough of South Greensburg is hereby amended at Section 163-19.J. as follows: "Restaurant and bar, providing live entertainment or dancing for not more than four (4) events in any calendar month. Any request by a restaurant or bar for additional events not exceeding six (6) in any calendar month shall be subject to a permitting process established by the Borough."

All other provisions of the said Zoning Ordinance are to remain effective and in force.

All Ordinances, or parts of Ordinances, inconsistent herewith, be and the same are hereby repealed.

**ESTABLISHING A LIVE ENTERTAINMENT
PERMITTING PROCESS AND A SCHEDULE OF
PERMIT FEES.**

The following fees are hereby established by South Greensburg Borough Council for matters associated with the South Greensburg Borough Zoning Ordinance, Section 163-19.J (as amended by Ordinance Nos. 2012-06 and 2013-06) relating to live entertainment.

SECTION 1. ESTABLISHMENT OF PERMITTING PROCESS.

- A. A restaurant or bar may hold not more than four (4) live entertainment or dancing events in any thirty (30) day period.
- B. Any request by a restaurant or bar for additional events not exceeding six (6) in any thirty (30) day period shall be subject to a Live Entertainment Permit.

SECTION 2. PERMIT FEES.

- A. The fee for a Live Entertainment Permit shall be \$25.00 for each additional event not exceeding six (6) in any thirty (30) day period.

This Resolution shall become effective immediately upon enactment.
