Rosensteel stated not sure if the Parent's Association will open concessions. Also stated in 2018 the Parents Association paid \$1250.00 for safety equipment for each team, paid a portion for the Gator, and \$250.00 for the Western Concession stand, and \$900 in tournament fees.
