NEW PAVING SHALL NOT BE OPENED FOR A PERIOD OF FIVE YEARS AFTER THE COMPLETION OF NEW PAVING, EXCEPT IN CASE OF AN EMERGENCY.

Emergency openings. In the case of any leak, explosion, or other accident in any subsurface pipe, line, construction or apparatus, it shall be lawful for the person owning or responsible for such pipe, line, construction or apparatus to commence an opening or excavation to remedy such condition before securing a permit, provided that, application for a permit shall be made immediately and **not later than the next business day thereafter**, and that all other provisions of this article shall be fully complied with.

Payment for all work done by the Borough under the provisions of Chapter 144, Article II, shall be made by the person made liable therefore under these provisions hereof within 30 days after a bill is sent to such person by the Borough. Upon failure to pay such charges within such time, the same shall be collectible by the Borough in the manner provided by law for the collection of municipal claims.

Any person who shall violate any provisions of this article shall, upon conviction thereof, be sentenced to pay a fine not less than \$50 and not exceeding \$300 and costs or shall be imprisoned for not more than ninety (90) days, or may be punished with both fine and imprisonment. Each day that a violation of this Article continues shall constitute a separate offense.

Upon signing you understand and agree to all provisions, conditions and terms in Chapter 144, Article II "Street Excavation Ordinance of the Borough of South Greensburg."
