CITIZEN'S REMARKS:

Resident Pelinchar spoke of his concern on the Regulated rental unit, in which, his properties do not apply. Mr. Martin went on to explain that unless there is a complaint filed from a tenant of a safety concern with the property, the borough will not ask to do a rental inspection check on the property.

BUILDINGS & GROUNDS: Fire Dept. mentioned to Bartley they have a garage door bay (3rd door) that they want an opener for. Rosensteel said they have money in their budget, the fire department can pay for it.

STREETS & SANITATION:

Greenridge Landfill 5year agreement discussed. Also Yarnell contacted Trucks and Parts in Downingtown and they offered to give borough 15k for the old garbage truck. This has been the best offer thus far and Yarnell has been reaching out to multiple companies over the past month.

FIRE & WATER: Mr. Rosensteel read the fire report.

PARKS & RECREATION: Tarps for ball fields: Was money released for the tarps to be ordered? Dobies said she needs to look into it.

PLANNING, ZONING & CODE ENFORCEMENT: Hopkins spoke on several of the houses she is still working on regarding blight.

Zoning: Broad Street Dairy building: As per zoning officer Peticca and Solicitor Kansler's our code requires parking regulations be met in case of "development" Development is defined as "the division of a parcel of land into two (2) or more equal parcels; the construction, reconstruction, conversion, structural alteration, relocation or enlargement of any structure; any mining, landfill disturbance, or extension of the use, of land. In this case, it is currently a restaurant and will continue to be a restaurant.

This building was constructed before the zoning laws were around and would therefore be considered a valid non-conforming use.

ENGINEER'S REPORT: Regola spoke that the plans are moving forward and getting finalized for the new playground.
