Lessee forfeits security deposit for any cancellations made less than thirty (30) days prior to the rental date. The security deposit shall be used by the Lessor to pay the cost of any clean up, breakage or damage to the Demised Premises. Lessor may grant credit to the Lessee to the extent the Lessee assumes clean up obligations and to the extent there is no breakage or damage to the Demised Premises. The balance, if any, of said security deposit shall be refunded to the Lessee. Determination of Lessor as to expense of clean up and cost of breakage or damage to the Demised Premises shall be binding and conclusive upon all parties.

\_\_\_\_\_ The Lessor shall not be subject to liability for any injury or damage to any person or to any property at any time on said premises or building from any cause whatever that may be at any time exist from the use or condition of said premises or building.

\_\_\_\_\_ Lessee agrees to an extra fee of \$25.00 to obtain the right to consume alcohol on the premise and be of legal age. Glass bottles NOT permitted.
