

NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of South Greensburg, in regular meeting assembled and by authority of the same:


SECTION 1. That the Republic Services Disposal Agreement, in the form submitted and attached as Exhibit "A," and incorporated by reference herein, hereby approved.

NOW, THEREFORE, BE IT RESOLVED by Council of the Borough of South Greensburg in a regular meeting assembled and by the authority of the same:


SECTION 1. The Borough of South Greensburg hereby approves and adopts the South Greensburg Comprehensive Plan 2019.

**RESOLUTION TO RECOMMEND THE STATE LEGISLATURE TO AMEND  
THE RIGHT TO KNOW LAW AND PROVIDE RELIEF FROM VEXATIOUS  
REQUESTERS**

**WHEREAS**, the current Pennsylvania Right to Know Law allows a single individual to submit an unlimited number of requests to a public body;

**WHEREAS**, requests for information are not subject to disclosure of their purpose;

**WHEREAS**, it is believed that select Pennsylvania communities are suffering from vexatious requesters whose intent is to harass and/or overburden the public body and/or public employees;

**WHEREAS**, the current Pennsylvania Right to Know Law states, “citizens should use good judgment in seeking records from the public body and not use this law to harass or overburden a public body from performing its job”;

**WHEREAS**, the Law provides no relief or recourse for a public body, to deter citizens who use the law to harass or overburden the public body;

**WHEREAS**, it is believed that selected communities and public bodies are suffering from vexatious requesters who cost local taxpayers funds in labor, attrition of overwhelmed employees, hiring additional staff to answer requests, and solicitor costs to defend appeals; and

**WHEREAS**, it is believed that the current Right to Know Law is being abused by vexatious requesters who are using the law as a retaliatory weapon, rather than for the public good.


**NOW THEREFORE** be it resolved, that Borough of South Greensburg Council urges the Pennsylvania State Legislature to enact an amendment to the Right to Know Law that would:

1. Define the words, “harass” and “overburden” in the current Right To Know Law.
2. Alternatively, provide a venue of remedy for a public body to solicit relief from the Office of Open Records or the Courts, to address those who could be recognized as a “Vexatious Requester.”

**AUTHORIZING THE DISPOSITION OF PUBLIC RECORDS**

WHEREAS, the Borough of South Greensburg desires to destroy records as appropriate, pursuant to the Municipal Records Manual, dated December 26, 2008, and amended July 23, 2009; and,

WHEREAS, in accordance with Act 428 of 1968, each individual act of disposition of public municipal records shall be approved by Resolution of the governing body of the municipality.

NOW, THEREFORE, BE IT RESOLVED by Council of the Borough of South Greensburg, in regular meeting assembled by authority of the same:

SECTION 1. That the Council of the Borough of South Greensburg, Westmoreland County, Pennsylvania hereby, to the extent that it has not already done so, adopts the Municipal Records Manual as approved December 26, 2008, and amended July 23, 2009, as its records disposition policy, a copy of which shall be on file with the Borough Secretary.

SECTION 2. That the Borough in accordance with the above cited Municipal Records Manual authorizes the destruction of public municipal records as appropriate and set forth in said Manual, and as specifically identified in Exhibit A, attached hereto and incorporated by reference herein.

SECTION 3. That the Borough Secretary, Chief of Police, and any other proper Borough officer be and are hereby authorized and directed to carry out the disposition of the public municipal records as set forth on the attached exhibit and as set forth in the Municipal Records Manual.


SECTION 4. That the within Resolution shall become effective immediately upon passage.

SECTION 5. That any and all other Resolutions inconsistent herewith are hereby repealed.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of South Greensburg, in regular meeting assembled and by authority of the same:



WHEREAS, the Municipal Authority of Westmoreland County (MAWC) damaged the traffic signal at the intersection of Route 119 and Fairview Avenue in the Borough of South Greensburg;

WHEREAS, the contract for the repair of the traffic signal is for the routine repair of existing infrastructure and public works of the Borough and is expected to be less than \$17,000; and

WHEREAS, MAWC and the Borough of South Greensburg desire to enter into a cooperative purchasing agreement to facilitate the repair of the damaged traffic signal, pursuant to 62 Pa.C.S.A. Section 1902.

NOW, THEREFORE, BE IT RESOLVED by Council of the Borough of South Greensburg in a regular meeting assembled and by the authority of the same:




