**Motion by Yarnell and seconded by Kelsey to lend the backhoe to Greensburg Salem School District for them to borrow when needed.**

**Mr. Martin- we will resume the June Agenda and Council meetings in person in Hirst Hall and if needed hold a zoom meeting in conjunction with the regular meeting.**

**Mr. Fajt- Currently have \$3,151.69 in COVID-19 supplies that will be submitting to PEMA. Will open Park for walking and exercise following social distancing guidelines. There are currently no pavilion rentals for the month of May and the June concert in park is postponed. Tennis courts, basketball court and ballfields will be open for leisurely use- no organized or team sports permitted at this time- following all guidelines based on Governor Tom Wolf. Recreation is on hold for June.**
