3. Meetings

Rental \$125.00, Damage Deposit \$75.00

4. Funerals

Damage Deposit- \$75.00

Residents- Rental \$50.00

Non-Residents \$150.00

5. Local Non-Profit

Rental \$50.00, Damage Deposit- \$75.00

6. Non-Profits out of Borough

Rental \$150.00, Damage Deposit \$75.00

7. For Profit Activities

Rental \$325.00, Deposit \$75.00

Consumption of Alcohol Permit: \$25.00 per day

SECTION 3: By paying the above fee and signing any permit application materials, the applicant agrees to be subject to and comply with all rules and regulations as set forth by the Borough in relation to the permit requested and the property used by the applicant.

That the Mayor, Borough Council President, and Borough Secretary of the Borough of South Greensburg, and/or any other proper officer or employee of the Borough of South Greensburg, are hereby authorized and directed to take any and all action and sign any and all documentation necessary to carry into effect this resolution.
