- Tom Yarnell spoke about the need to charge a fee for removal of large garbage items that are not part of the normal pickup at the discretion of public works. George Cole stated that there must be a change then for unlimited pickup fee rates. Council agreed there needs to be more discussion and thought put into a fee schedule before making a motion.
- Clentin Martin spoke about the need to update the employee handbook and this is a topic that will be placed on September's Agenda. And reminded everyone to take a look at any ordinances that may need updated or altered.
