

**RESOLUTION NO. 2- 2021**

**A RESOLUTION OF THE BOROUGH OF SOUTH GREENSBURG,  
COUNTY OF WESTMORELAND AND COMMONWEALTH OF  
PENNSYLVANIA, APPROVING THE TRANSFER OF  
RESTARUANT LIQUOR LICENSE NO. R-19824 INTO THE  
BOROUGH OF SOUTH GREENSBURG**

**BE IT RESOLVED AND ENACTED** by the Council of the  
Borough of South Greensburg, Westmoreland County, Pennsylvania, as  
follows:

**WEREAS**, Act 141 of 2000 (“the Act”) authorizes the Pennsylvania Liquor  
Control Board to approve, in certain instances, the transfer of restaurant liquor  
licenses across municipal boundaries within the same county regardless of the quota  
limitations provided for in Section 461 of the Liquor Code if, as in the Borough of  
South Greensburg, sales of liquor and malt or brewed beverages are legal in the  
municipality receiving the license; and

**WEREAS**, the Act requires the applicant to obtain from the receiving municipality a  
resolution approving the inter-municipal transfer of the liquor license prior to an applicant’s  
submission of an application to the Pennsylvania Liquor Control Board; and

**WEREAS**, the Liquor Code stipulates that, prior to adoption of a resolution by the  
receiving municipality, at least one hearing be held for the purpose of permitting  
individuals residing within the municipality to make comments and recommendations  
regarding applicant’s intent to transfer a liquor license into the receiving municipality, and

**WEREAS**, an application for transfer field under the Act must contain a copy  
of the resolution adopted by the municipality approving the transfer of a liquor license

into the municipality.

**NOW, THEREFORE, BE IT RESOLVED**, that Sheetz, Inc. has requested the approval of the Borough of South Greensburg for the proposed transfer of Pennsylvania restaurant liquor license no R-19824, from The Auronzo Corporation, 2249 Valley

Green Road, Hempfield Township, Greensburg, Westmoreland County, Pennsylvania 15601 to Sheetz, Inc. for restaurant facilities within the Borough of South Greensburg to be located at 1312 South Main Street, South Greensburg Borough, Westmoreland County, Pennsylvania 15601 with the understanding that the liquor license will be transferred to only that location. Further, said transfer must be approved at a later date by the Pennsylvania Liquor Control Board; and

**BE IT FURTHER RESOLVED**, that the Borough of South Greensburg has held a properly advertised public hearing pursuant to the notice provisions of Section 102 of the Liquor Code to receive comments on the proposed liquor license transfer; and

**BE IT FURTHER RESOLVED** that the Borough of South Greensburg approves, by adoption of this Resolution, the proposed inter-municipal transfer of restaurant liquor license No. R- 19824 into the Borough of South Greensburg by Sheetz, Inc. and

**BE IT FURTHER RESOLVED** that transfers, designations and assignments of licenses hereunder are subject to approval by the Pennsylvania Liquor Control Board.
